

Unit 1

Financial Situations in a Corporation

公司財務狀況



A corporation is a complex legal entity organized around the principles of balancing risk and profitability, while increasing in value for its stockholders—those members of the public who through the purchase of shares, help finance operations. A variety of financial instruments, such as bonds and long-term credit, provide further funding, but it is the selling of publically traded stocks that necessitates management by a board of directors, compliance with a myriad of governmental regulations, strict self-policing to prevent insider trading, and intense scrutiny of profit and loss statements and other forms of financial reporting.

「公司」是複雜的法定實體,為一考量平衡風險和獲利原則而建立的組織。同時,為了維護股東利益,公司必須不斷增加自身價值。「股東」即為買進公司股票,協助其籌措營運資金的民眾。債券和長期信貸等金融工具,都可為公司提供更多的資金,但只有銷售公開交易的股票時,才須由董事會來管理,並且要遵守種種政府法規,嚴格自律以防止內線交易,也須密集檢視財報損益,和其他形式的財務報告。


PROFIT AND LOSS 損益

The Profit and Loss Statement 損益表 №01

The bottom right chart illustrates the **break-even point**¹ of any business. As you can see, the breakeven point is the point in the annual output² where the number of units sold, or number of services provided, produces enough gross³ profit⁴ to cover total costs, including **fixed**⁵ overhead⁶ costs⁷ of operations.



Loss⁸ occurs whenever fixed costs exceed sales⁹. Profit occurs whenever sales exceed total costs. As you can see in the right graph, the break-even point for this company is reached when 5,000 units are sold. It is at this point that total sales (or gross profit) equal total costs. Now we'll look at a Profit and Loss Statement¹⁰



A P&L statement starts with the gross income¹¹. Any discounts or allowances are subtracted to arrive at **net**¹² income. Cost of sales (in this case, purchases and shipping) is then taken to give gross profit. Gross profit margin is calculated as gross profit divided by total sales.

Overhead (which includes rent for your premises, marketing costs, wages, telephone, postage, stationery, etc.) is then subtracted. The remainder is operating profit.

Tax is then taken away from operating profit to arrive at net profit or loss. You may now calculate your net profit margin as net profit divided by total sales.

By looking at both the break-even point and the profit and loss statement, you can get a quick feel for the basic economics underlying profit and loss of a corporation. In the next section, we will look at stocks and how they affect the profits and loss of a company.

右下圖顯示企業的「損益平衡點」(breakeven point,或譯收支平衡點)。如圖所示, 損益平衡點係指銷售量或所提供的服務之年產 出,其創造的毛利足以因應所有成本開銷,包 括營運的固定經常性支出。

固定成本超過**銷售額**即產生**虧損**。銷售額超過總成本即產生獲利。如右圖所示,當此公司銷售5,000個產品時,即達到損益平衡點。在這一點時,總營收(或毛利)等於營運總成本。現在我們來看看**損益表**。

損益表一開始會列出總**收入**,減去折扣或 折讓而得出**淨**收入,再減去銷售成本(在此為 進貨成本和運輸費用)即為毛利。毛利率的計 算方式為毛利除以總營收。

之後再減掉管銷費用(包含辦公室租金、 行銷費用、工資、電話費、郵資及文具等), 餘額即為營業利潤。

營業利潤再扣去税項,即為淨利或淨損。 你現在可以用淨利除以總營收,來計算淨利 率。

經由損益平衡點和損益表,你可以很快 了解公司損益的基本狀況。在下一節,我們要 看的是股票,以及它們如何影響一家公司的盈 虧。



你知道嗎?

商業用語中的「虧損」(in the red)及「盈利」(in the black),源自於在會計實務上,<mark>赤字</mark>表示公司的虧損,黑字表示獲利。




1. break-even point (n. phr.)

損益平衡點,即總收入線與總成本線的交叉 點。係指一營利事業體所賣出的商品,或提供 的勞務數量,其所產生的收入,恰足以彌補所 有相關成本的生產水準點。

產出;產量,指在生產過程中,在特定期間內 所創造各種物品或勞務的數量或總量。




3. gross [gros] (a.)

毛的;總的,指未扣除各項費用、稅額或相關成 本的。毛額指的就是未扣除「固定資本消耗」之 價值。



4. profit ['prafit] (n.)

獲利; 利潤, 扣除掉薪資、租金、原料等相關成 本後的財務盈餘。即總收入減去總成本後的差



5. fixed [f1kst] (a.)

固定的,不會隨時間改變而變動的狀態。



6. overhead (burn rate) ['ova'hed]

經常性支出(俗稱資金消耗率、燒錢率),指 維持企業日常營運所需,非因特定產品生產或 營運所產生的費用支出,如租金、電費等。即 企業界的營運、管銷費用,或指間接成本。

7. cost [kɔst] (n.)

成本,指企業為生產商品和提供勞務等,所花費 或付出的金額。

9. sales [selz] (n.)

銷售額,指企業售出商品或勞務給消費者,所得到的款項、營收。



11. income (revenue) [\in,k\lambdam] (n.)

所得(收入),銷售商品勞務給消費者所得到的 金錢。

8. loss (deficit) [los] (n.)

損失(赤字),指成本減去收入的貨幣總額。

10. profit and loss statement (n. phr.)

損益表,顯示企業在某一會計期間的總收入、銷 貨成本、營運成本和最後淨利(或淨損),用以 顯示該期間之經營成果。



12. net [nɛt] (a.)

淨額的;淨值的,在扣去相關要素之後,所剩餘的數量或分額,如淨獲利等於營收減去相關成本之差額。

13. gross margin (n. phr.)

毛利率,毛利占銷售收入的百分比,即將毛利除 以商品單位售價所得之百分比。毛利率為產品獲 利能力的指標,公式為:

毛利率=(營業收入-營業成本)/營業收入。

14. volume [ˈvaljəm] (n.)

量,泛指公司賣出的商品數量,或提供給消費者 的服務時數。


